ORDER:

Thiru V.Chandrasekar three time National Champion in Table Tennis, former India International and Arjuna Awardee has requested the Government to allot four grounds of land to put up a structure with a floor area of 7500 sq.ft. to build an International Table Tennis Centre at Madras.

2. The Managing Director, Tamil Nadu Housing Board in his letter second read above has stated that as per the approved layout plan of Mogappair Eri Scheme, the site requested for allotment is earmarked for Fire Station. The total extent of the above site is 4 grounds and 0090 sq.ft. Thiru V.Chandrasekar, Director of Chandra's Table Tennis Coaching Centre has agreed to take up the above site.

3. The Government after careful consideration accept the request of the Director, Chandra's Table Tennis Coaching Centre and have decided to allot a site measuring 4 grounds and 0090 sq.ft. at Mogappair Eri Scheme, earmarked for Fire Station to the Director, Chandra's Table Tennis Coaching Centre, on lease basis for 10 years at a nominal annual rent of Rs.1,000/- per ground.

4. The Managing Director, Tamil Nadu Housing Board is requested to send necessary proposals to the Madras Metropolitan Development Authority for change of land use of the site referred to above in the layout, and for provision of alternative public purpose site for Fire Station in the layout.

5. The cost of the above site will be met from Chief Minister's Public Relief Fund. The Managing Director, Tamil Nadu Housing Board is requested to take necessary action for the transfer of the above land to the Collector of Madras. The Collector of Madras

after making entries in the Land Register about the site referred to is requested to obtain a lease deed in the usual format with reference to the orders issued in paragraph 3 above.
